The Department of Education and Training funding covers the delivery of only some of our standard curriculum. It does not cover the additional funding required to deliver our specialist programs.

You have chosen to attend our school via the audition process and we strongly believe that education is about much more than just curriculum. VCASS strives to support your child to grow, not just academically, but emotionally, culturally, socially and artistically.

## **Financial Support for Families**

VCASS understands that some families may experience financial difficulty and offers a range of support options, including:

- Flexible payment arrangements are available through our compass system.
- Conveyance Allowance (if eligible) Reimbursement of yearly travel ticket provided by the State Government will be allocated to family accounts. Parents can agree for this reimbursement to go toward Curriculum Contributions via Compass in 2023. Refunds will be made to any family upon request or when students leave VCASS. Families can choose to donate the balance to the school.
- CSEF The CSEF provides payments to assist eligible families to cover the costs of camps, sporting
  activities and excursions and is available to parents with a means-tested concession card. CSEF
  payments will be processed directly to schools from March 2023. If you have received CSEF in 2022
  you do not need to reapply through the school.

## **Payment methods**

Parents and guardians will be provided with notice of payment requests prior to the new school year.

Our preferred payment option is via your Compass log in. Payments through Compass are made in full, or via a Payment Plan where payments can be made in instalments at regular intervals. Payments may also be made at Reception or via credit card over the telephone.

## Refunds

Refunds will be worked out on a case by case basis at the local school level.

• VCASS has the discretion to provide refunds to families and will do so where it is reasonable and fair (for example, if the school has not incurred a cost).

• If VCASS has incurred costs, the school will act reasonably and take into consideration the Financial Help for Families Policy and relevant arrangements, including support for families experiencing hardship. VCASS will consider refunding families for:

- $\circ$  unavoidable event cancellations
- $\circ$  if a family experiences a crisis or sudden serious illness
- $\circ$  the student can no longer attend the event.

• If VCASS decides to provide a refund, then parents need to agree and advise the school where the refund should be paid. If that agreement cannot be reached, the refund will be paid into the account from which the money came. Where the payment was made in cash, VCASS will wait until the parents reach an agreement and advise the school.

## **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

## PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

### **Curriculum Contributions**

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

## FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



## SCHOOL PROCESSES

• Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
